

## **SECTION 341 MEETING LOCATIONS (FIRST MEETING OF CREDITORS)**

Section 341 meetings of creditors in bankruptcy cases (sometimes referred to as the 'first meeting'), at which the debtor is orally examined by the trustee, are NOT conducted by the Court; under statute, the U.S. Trustee convenes and presides at the Section 341 meeting. In this District, the U.S. Trustee has arranged for meetings to be conducted at the following locations:

## **DIRECTIONS TO 341 MEETING ROOMS**

### ***BROOKLYN***

**(111 Livingston St., Suite 1102)**

**BY CAR FROM BROOKLYN (FLATBUSH AVE. HEADING TOWARD MANHATTAN):** Take Flatbush Ave. to Livingston St., turn left on Livingston St., building is on the right, parking lot is next to building.

**BY CAR FROM BELT PARKWAY WEST, STATEN ISLAND:** Take Brooklyn-Queens Expressway (B.Q.E.) to Atlantic Ave. exit, turn right on Atlantic Ave. to Clinton St. (two traffic lights), turn left on Clinton St. to Livingston St. (two traffic lights), turn right on Livingston St., building is on the left, parking lot is next to building.

**BY CAR FROM QUEENS, LONG ISLAND:** Take B.Q.E. to Tillary St. exit, take Tillary St. to Jay St. (three traffic lights), turn left on Jay St. to Livingston St., turn right on Livingston St., building is on the right, parking lot is next to building.

### **PUBLIC TRANSPORTATION**

BY SUBWAY:

● **IND A, C or F** train to **Jay Street-Borough Hall** - Exit station, proceed west on Fulton St. to Boerum Pl., turn left on Boerum Pl. one block to Livingston St., turn right on Livingston St., building is on the right.

● **IND G** train to **Hoyt-Schermerhorn**, transfer to **A or C** to **Jay Street-Borough Hall** (see above)

● **IRT 2, 3, 4 or 5** train to **Borough Hall** - Use Court St. exit, walk three blocks south (**2,3**) or one block south (**4,5**) to Livingston St., turn left on Livingston St., building in on the left.

● **BMT N or R** train to **Court Street** - Use Court St. exit, follow directions for **IRT** above. [NOTE: After approx. 3 p.m., **M** train can also be taken to **Court Street** station.]

BY BUS:

The following routes stop at the corner of **Livingston and Court Streets**:

**B37 B45 B51**

The following routes stop at the corner of **Boerum Place and Fulton Street**:

**B25 B52 B65**

### **BY FOOT FROM THE COURTHOUSE (75 CLINTON STREET)**

Turn left when leaving the Courthouse, walk three blocks to Livingston Street and turn left, cross Court street, building is on your left.

## **DIRECTIONS TO 341 MEETING ROOMS**

### ***CENTRAL ISLIP***

**(Long Island Federal Courthouse, Federal Plaza, Rooms 561, 562 & 563)**

**BY CAR:** The Long Island Federal Courthouse is located at the intersection of Exit 43A of the Southern State Parkway and Carlton Avenue in Central Islip, New York. Coming from the north, take the Long Island Expressway and exit at southbound Route 111, and follow the signs to Carlton Avenue. The court is on the left, just south of the New York State Cohalan Court Complex.

**BY RAIL:** The Central Islip station of the Ronkonkoma Branch of the Long Island Railroad leaves you about 2-1/2 miles north of the Courthouse. Suffolk County Transit's Bus Route 3C (southbound) will take you from the railroad station to the Cohalan Court Complex. Taxis are also available at the station.
