ECF Filings

The court is extremely pleased with the local bar's response regarding the use of the ECF system.

The monthly percentages of attorney ECF filings for the past three months of 2003 are as follows:

Event Docketing	17%	19%	18%
Atty's Docketing	468	439	473

Heath Berger, David Doyaga, Richard Jacoby and Alan Nisselson have become the latest attorneys/trustees to docket more than one thousand events into the system this year. Sixteen others have docketed more than 500 events.

More than twelve hundred attorneys now have a login and password to docket into the system.

ECF General Order

Each month we feature a different section of the ECF General Order or our Local Rules. The General Order and Local Rules are on our web page and we ask all attorneys to review them before filing to ensure accuracy of submissions. This month we highlight Local Bankruptcy Rule 1073-2 (a).

LBR 1073-2 DISCLOSURE OF RELATED CASES

- (a) Definition of Related Cases.
 Cases shall be deemed "Related Cases" for purposes of E.D.N.Y. LBR 1073-1 and E.D.N.Y. LBR 1073-2 if the earlier case was pending at any time within six years before the filing of the new petition, and the debtors in such cases:
- (i) are the same;
- (ii) are spouses or ex-spouses;
- (iii) are affiliates, as defined in 11 U.S.C. § 101(2);
- (iv) are general partners in the same partnership;
- (v) are a partnership and one or more of its general partners;
- (vi) are partnerships which share one or more common general partners; or
- (vii) have, or within 180 days of the commencement of either of the Related Cases

had, an interest in property that was or is included in the property of another estate under 11 U.S.C. § 541(a).

Help Desk Question of The Month

Question: The creditor matrix was always submitted with the list of creditors center justified on the matrix. Is that the current procedure?

Answer: No. In ECF, all creditors must be LEFT JUSTIFIED on the matrix. If you center justify, you run the risk that addresses will be cut off.

Time Stamps

The time of an electronic filing is annotated on the Notice of Electronic Filing. This is the last page you receive after your docket entry. The time stamp is created when the filing is completed and is based on the time zone of the court. Therefore, the time stamp on any document filed in the Eastern District will be based on the Eastern time zone. Keep this in mind when you are filing from a different time zone.

Cache and Your Computer

Cache is a location on your hard drive where data is stored. When you search the

internet, your computer keeps track of every page you have visited and saves this information on your hard drive. We have found that if this file becomes large (i.e., many pages searched), the result may be a loss of docketing/category options. To clear your cache, perform the following:

For Netscape

- 1. On the **Edit** menu of your Netscape toolbar, click **Preferences.**
- 2. Under Category, click the **Advanced** selection.
- 3. Under Category, click the **Cache** selection.
- 4. Click **Clear Memory Cache**, then click **OK**
- 5. Click Clear Disk Cache, then click OK.
- 6. Click **OK** to exit.

For Internet Explorer:

- 1. On the **Tools** menu of your Internet Explorer toolbar, click **Internet Options**.
- 2. Click the **General** tab.
- 3. In the Temporary Internet Files area, click **Delete Files**, and then click **OK**.
- 4. Click **OK** to exit.

ECF Version 2

Anticipated Release Date-November 12, 2003

We will install the next version of the ECF

system (Version 2) into our live database in November. For those of you who have a training password, you can take a look at Version 2 in our training database located at https://ecf-train.nyeb.uscourts.gov/. Please be advised that all cases were deleted from the training database. To find new cases that currently exist, please run a **Cases Report** from under the **Reports** menu. Most of the changes will not be noticeable, however, there will be some minor variations to the screens. We will distribute an information guide outlining these changes to you prior to the live date.

Filing Amended Schedules

If you are filing Amended Schedules, please select the event **Amended Schedules** from the **Other** category.

Do not use **Open a Bankruptcy Case** for anything other than the initial filing of a petition.

Adobe Acrobat Hint

If you want to copy a PDF file to your word processing program, perform the following:

- a) Save the PDF file to your computer
- b) Open Adobe Acrobat
- c) Open the file
- d) Select Edit-Copy File to Clipboard
- e) Open the word processing program
- f) Select Edit-Paste

g) Save the file

The document font and format will change, however, you do not have to retype all of the text. Please be advised that this will not work if the PDF document was scanned from paper.

Reminders

- There is no limit to the number of aliases a party may have.
- Be careful when forwarding spam e-mail to your internet provider for blocking. If you accidently forward an e-mail from the court to your ISP, your ISP will block all incoming e-mail from the court including the free look e-mails.
- If your e-mail address is hotmail.com, please be advised that your free e-mails may be automatically delivered to your junk mail folder. If this is the case, please go into your junk mail folder and check off "This address is not Junk mail."
- When you scan a document, scan it in portrait, not landscape mode whenever possible.
