## **"GO LIVE DAY"**

## January 19, 2021

The United States Bankruptcy Court for the Eastern District of New York will begin upgrading its Case Management/Electronic Case Filing System (CM/ECF) to the Next Generation of CM/ECF (NextGen). **This will require CM/ECF to be offline from 5:00 p.m. on Thursday, January 14, 2021, through Monday, January 18, 2021.** During this time access to Querying and Docketing will be unavailable. The Court's Electronic Document Upload Program will be available at <u>https://www.nyeb.uscourts.gov/content/pro-se-electronic-documentupload-program</u>.


To electronically file in this Court on January 19<sup>th</sup> and thereafter, existing CM/ECF account holders must link their CM/ECF accounts (login and password) to their upgraded PACER accounts. Linking is a one-time process that can be completed only after the Court is live on NextGen CM/ECF. Follow the procedure below to link.

**STEP 1.** Go to the court's CM/ECF site: <u>https://ecf.nyeb.uscourts.gov/</u>. Select **Eastern District of New York Document Filing System** link. (You will be on the NextGen CM/ECF Live Screen).


**STEP 2.** Enter your **upgraded PACER Username and Password.** Client Code is optional and is used for your case management.
