Because of time constraints, the attorney filing the Adversary Proceeding must check his or her e-mail or the case docket within two days from the date of filing the Adversary Proceeding to download the Summons for service. If the Summons has not been generated within three days, contact the Clerk's Office immediately.

Filers must keep in mind that opposing counsel for defendant will not get electronic notification of any filings for the Adversary Proceeding until opposing counsel files on the case. The Notice of Electronic Filing is helpful in determining who has been noticed.

The **Notice of Electronic Filing** is the receipt evidencing the filing of the Affidavit of Service for the Summons and Complaint. Any filer with an ECF login and password who dockets on the case receives this **Notice of Electronic Filing** (NEF) in his or her e-mail account. This NEF receipt alerts e-filers who have docketed up to this point on the case that the Affidavit of Service for the Summons and Complaint has been filed.

The Notice of Electronic Filing also indicates the date and time the Affidavit is filed.

**Document Number** - in the e-mail, filers must select the **Document Number** hyperlink to view the Affidavit. This is referred to as the FREE LOOK. If the filer loses the free look, the filer must query the docket through PACER.

**Docket Text** - duplicates the Final Docket Text as it appears on the docket.

**Notice will be electronically mailed to** - Identifies the parties in the case who will receive electronic notice of the filing in their e-mail account.

**Notice will not be electronically mailed to** - Identifies the parties in the case who will not receive electronic notice of the filing and must be served conventionally.
