# **Chair Update and Approval of Minutes:**

Chair Michelle McGreal asked for comments on the minutes of last meeting, there being none, a motion was made for approval of the minutes of the last meeting – the minutes were approved.

## **Board of Judges Update:**

Chief Judge Craig provided an update on chapter 11 filings noting that the number of filings is up 6% from last year through 9/30/19. The EDNY is 3rd in the country in the number of new filings. Chief Judge Craig advised that the Court submitted the Local Rules to the District Court for approval and expected an approval within a couple of weeks. Chief Judge Craig also reported that the Court held a very successful junior lawyer workshop stating that there were 33 people who registered, there were some drop offs, but still an active and lively group. Judge Stong noted that there were maybe 4-5 year attorneys without court experience participating. Judge Stong received positive feed back from the participants. Burt Weston commented that his associate had a terrific experience. The Judges expressed appreciation for the Committee members, deputies and Court staff for providing their time. Chair Michelle McGreal questioned whether any other courts have rolled out similar programs. There was discussion regarding reaching out to the NYC Bar Association, the TMA, and the NCBJ to assist with expanding the program to other courts. The Central Islip session is scheduled for December 18<sup>th</sup>.

### **Local Rules Project Update:**

Chief Judge Craig advised that the Amended Local Rules were sent to the District Court for approval.

#### Subcommittee Reports:

Large Chapter 11 Case Subcommittee:

The Committee discussed potential new projects for the Subcommittee, including local rules/guidelines for litigation financing and a local rule requiring financial advisors to provide disclosure regarding their IT protections.

Small and Medium Chapter 11 Case Subcommittee:

Dawn Kirby is looking into a small case chapter 11 plan. Chief Judge Craig suggested a training seminar on the SBRA and suggested we ask Bill Harrington to be on the panel. There was a suggestion to have a joint program with the N.Y. State Bar Association regarding changes to regarding preference actions.

Mediation Subcommittee:

No update – the Subcommittee is scheduling another brown bag session for the spring.

Junior Lawyers Initiative Subcommittee:

### Discussion of Potential New Projects/Subcommittees:

It was discussed and determined that the Committee would undertake two new projects, one to review and make recommendations for revisions to the Local Forms and another to review and make recommendations for revisions to the ECF e-filing events.
