SETTLEMENT CONFERENCES

- **FRPSC** attorneys to meet with Defense Bar and CBO to determine their settlement conference participation and readiness.
- **SELF-REPRESENTED LITIGANTS**
 - **Appear with Defense Bar, CBO, unless opt out.**
 - **Promotes access to justice and expedites process.**
 - **Come prepared – All pertinent financials with completed forms to be submitted to FRPSC 30 days in advance.**
 - **Conference cannot be held without forms and financial proofs. Limited adjournments with affirmations.**
 - **30 days from submission to complete process with FRPSC if not - then final to FSR-FRP (before Judge).**



MOTIONS

- **Motion calendar**: T/W/Th Mornings- **VIRTUAL** until further notice.
- First call 9:30am; Second Call 10:30am
- **Oral arguments**, if warranted, brief and specific with motion page cite to corroborate.
- **Priority Motions**- 2017 and before- attorneys **by 2/28** to calendar call to **email** to Law Clerk **and** Part Clerk brief procedural history and status update indicating whether settlement possible.
- **Meet with designated banks- determine willingness to settle, and those cases to move forward to sale.**
