**MOTION AND CERTIFICATION TO EXTEND THE CHAPTER 13 PLAN
REPAYMENT PERIOD PURSUANT TO BANKRUPTCY CODE SECTION 1329**

_____ [NAME] hereby moves for the entry of an Order to amend their Chapter 13 Plan pursuant to Bankruptcy Code Section 1329, in order to extend the repayment period under the Plan. In support of the Motion, I respectfully state and certify as follows:

BACKGROUND

1. On _____ [PETITION DATE], I filed a voluntary petition under Chapter 13 of the Bankruptcy Code in the United States Bankruptcy Court for the Eastern District of New York.

2. On _____ [DATE OF CONFIRMATION ORDER], the Court entered an Order confirming my Chapter 13 Plan. I have attached copies of my Chapter 13 Plan and the Order confirming the Plan to this Motion as Exhibit A.

3. I made the payments required under my Chapter 13 Plan through _____ [DATE]. But I have been severely impacted by the COVID-19 pandemic and public health emergency, and I have been unable to make my Chapter 13 Plan payments since _____ [DATE].

REASONS FOR THIS REQUEST

4. The Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”) was enacted on March 27, 2020. The CARES Act adds Section 1329(d) to the Bankruptcy Code for a limited period (extended to March 27, 2022 pursuant to The Covid-19 Bankruptcy Relief Extension Act of 2021). This Section permits a debtor to request a modification to a Chapter 13 plan that was confirmed before March 27, 2020, if he or she has experienced material financial hardship caused, directly or indirectly, by the COVID-19 pandemic.

5. I have experienced material financial hardship caused by the COVID-19 pandemic as follows: _____
