IV. General Professional Experience

I was in private law firm practice continuously for more than 40 years primarily specializing in bankruptcy, loan workouts and related litigation, including traditional lender-borrower issues and disputes in Bankruptcy, Federal and State courts involving middle market and large syndicated loans. In addition, for a period of many years I represented a pharmaceutical distributor as national defense counsel in mass tort litigation and as the distributor's Chapter 11 product liability counsel.

I began practice at Bondy & Schloss in 1970. I left Bondy & Schloss as a partner in 1980 and joined Slade Moross Rahl Glatzer & Stamm which merged into Anderson Kill & Olick, P.C. in 1990. During a nine year period from 1999 to 2008, I served as Managing Stockholder of Anderson Kill and as the firm's CEO and COO. During my tenure as Managing Stockholder,

I led and oversaw the successful restructuring and informal reorganization of the Firm which, among other benefits, resulted in the trebling of its profits per stockholder.

As Managing Stockholder I informally and successfully mediated countless issues which arose among and between stockholders, associates and staff.

In 2008 I joined Reed Smith LLP as a senior partner in the Corporate Reorganization and Restructuring Group where I continued my practice until I retired from the firm on December 31, 2013. While at Reed Smith I was Chair of the New York Pro Bono Committee, a member of the New York City Bar Association Pro Bono and Legal Services Committee and the partner responsible for the Firm's participation in the New York Attorney Emeritus Program.
