#### **CM/ECF VERSION 4.2 HIGHLIGHTS**

The United States Bankruptcy Court for the Eastern District of New York upgraded to CM/ECF Version 4.2 December 1, 2011. This upgrade enhances the Electronic Case Filing system to include new bankruptcy events and forms relative to Bankruptcy Rules, 1004.2, 2003, 3001, 3002.1.



#### TIP OF THE MONTH

#### Relating or Linking Documents

A recommendation from the *Court/Bar Strategic Planning Committee on Attorney Education* is to create a tip of the month for ECF filers. For December 2011, the Tip of the Month describes the importance of and the process of relating or linking documents. Relating a document allows the filer to create an association between documents in a case. This allows for quicker and easier access to related documents on a matter.

If the document you are filing refers to an existing document on the case, relate it or link it! Relating a document is simple. When filing your document, check the box "Refer to existing event(s)."



Common examples of documents that should be related to existing events include:

- Answers/Responses
- Amended Pleadings and Motions
- Letters referring to a particular matter
- Letters of Adjournment
- Proposed Orders docketed separately

The following events should not be related:

- Amended Schedules
- Statements
- Chapter 11 Plans
- Chapter 13 Plans

We encourage you to share the Tip of the Month with those on your staff that assist with e-filing. ECF filers are reminded to docket and upload the **Affidavit Pursuant to LR 1009-1(a)**, to disclose the purpose for filing Amended Schedules D, E, or F.

#### **Email Information**

You do not need to register for an ECF password more than once but account holders **must** keep their email profile and email address current. You must request a new password if you change firms. ## U.S. BANKRUPTCY COURT FOR THE EASTERN DISTRICT OF NEW YORK ADOPTS NEW YORK STATE BAR STANDARDS OF CIVILITY TO GOVERN PRACTICE IN ALL CASES BEFORE THE COURT

"...as lawyers, judges and court employees, we are all essential participants in the judicial process. That process cannot work effectively to serve the public unless we first treat each other with courtesy, respect and civility..."

Upon the resolution of the Board of Judges, the United States Bankruptcy Court for the Eastern District of New York adopted the New York State Standards of Civility for the legal profession as guidelines for practice in all bankruptcy proceedings. These guidelines govern all attorneys admitted to practice in the Courts of the State of New York and are designed to set a standard of practice in the Court that will promote the professional, efficient, and effective practice of law, management and administration of cases in the bankruptcy process. As stated in the Preamble, "they are . . . intended to encourage lawyers, judges and court personnel to observe principles of civility and decorum, and to confirm the legal profession's rightful status as an honorable and respected profession where courtesy and civility are observed as a matter of course."

The adoption of these guidelines is intended to supplement the Bankruptcy Rules, the Federal Rules of Civil Procedure, and particularly Federal Rule of Civil Procedure 11 and Bankruptcy Rule 9011, that govern the conduct of parties and participants in matters pending before the Court. These guidelines are also intended to supplement the Local Bankruptcy Rules for the

Eastern District of New York, including LBR 1007-3(b), 1073-2(c), 2017-1, 2090-2, 3015-3, and 9011-1. The Federal, Bankruptcy, and Local Rules continue to apply to practice before the Court and the remedies set forth therein remain unchanged.

These guidelines were developed by the Commercial and Federal Litigation Section of the New York State Bar Association, adopted by the New York State Bar House of Delegates, and incorporated as Appendix A to the Disciplinary Rules of the Code of Professional Responsibility at N.Y. #### **COST SAVING MEASURES**

As a cost saving measure, Official Form B10 Proof of Claim will no longer be sent with the following:

- Notice of Meeting of Creditors for Chapter 11, 12, and 13 cases.
- Notice of Discovery of Assets.
- Notice of Reopening Case and Discovery of Assets.

Prior to these cost saving measures, the court did not send a Proof of Claim form with the Notice of Meeting of Creditors for Chapter 7 cases. Proof of Claim forms can be found on the court's website at: http://www.uscourts.gov/uscourts/RulesAndPolicies/rules/BK Forms Current/B 010.pdf.

**As a cost saving measure,** the Bankruptcy Noticing Center (BNC) will no longer send the following orders to the Trustee. The Notice of Electronic Filing (NEF) will be sent as the official court notice.

- Order to Close Dismissed Case
- Order to Close Automatically Dismissed Case
- Final Decree for Chapter 7, 12, 13 Cases
- Order to Close Reopened Case

#### ELECTRONIC TRAINING CLASS SCHEDULE

The Electronic Case Filing training classes for attorneys and their support staff will be held at the Brooklyn Courthouse on January 13, 2012, January 27, 2012, February 10, 2012 and February 17, 2012 from 9:30 a.m. to 1:00 p.m. Evelyn Torres is the presenter for these classes. The training room is in a secured area so attendees are asked to comply with the directions given by the Court Security Officers until Ms. Torres escorts them to the training room.

The Electronic Case Filing training classes in Central Islip are scheduled for January 20, 2012 and February 3, 2012 from 9:30 a.m. to 1:00 p.m. Dwayne Cox is the presenter for these classes. The training room is in a secured area so attendees are asked to wait by the kiosk in the lobby area of the courthouse until Mr. Cox escorts them to the training room.

It is important that attendees be on time for class. However, if you arrive late, go to the Clerk's Office on the second floor of the Bankruptcy Court in Central Islip and first floor in Brooklyn, to speak to the Intake Deputy who will announce your arrival or escort you to the training room. Participants must register before attending the class. If you register for a class and must cancel, call as soon as possible so someone else can use the slot.
