### III. General Professional Experience

I have been engaged in the private practice of law since 1968. I began my career as an associate with Kronish, Lieb, Shainswit Weiner & Hellman (which merged with Cooley Godward Kronish LLP, now Cooley LLP). After a brief period as a sole practitioner in New York City, I became a member of Meltzer, Lippe, Levy & Goldstein, P.C. (now Meltzer, Lippe, Goldstein & Breitstone, LLP). In 1979 I founded my own firm which became Levy & Schneps, P.C., first with offices in Great Neck, NY and then for many

years in Manhasset, NY. I withdrew from the firm in early 2014 to become of counsel to the Westerman Ball firm in Uniondale, NY so that I could focus on my ADR practice, and mediation in particular.

I began my legal career with an emphasis in the tax, corporate and securities fields. After approximately 20 years as a commercial transactional attorney, I turned more actively to commercial and Surrogate's Court litigation. In the late 1980s, I became an arbitrator with the National Association of Securities Dealers, Inc. (NASD, now FINRA). In 1993, I went on to the arbitration panel of the American Arbitration Association where I currently serve on its Complex Commercial Case panel. I have provided mediation services since 2005.
