III. General Professional Experience:

Upon graduation from law school I practiced as a corporate lawyer specializing in securitizations for one year, prior to becoming a bankruptcy lawyer. I have worked as a bankruptcy lawyer for over fifteen specializing in all aspects of commercial bankruptcy.
